# Health and Safety Policy Statement

It is the policy of the management of BAE SYSTEMS Avionics Limited to do all that is reasonably practicable to ensure a safe and healthy working environment.

It is the duty of all management and supervisory staff to maintain a safe and healthy place of work to ensure that everything reasonably practicable is done to prevent personal injury or damage to property in the process of production, design and test, construction, operation and disposal of all plant, machinery, equipment and services.

The Company will provide appropriate instruction, training, supervision and information to enable all employees to perform their work safely and efficiently. Training will be provided to employees to ensure that all are aware of their duties and responsibilities and that health and safety is a prime consideration in all aspects of their work and the work of contractors and visitors on company premises.

The Company will emphasise in all health and safety matters the high degree of individual personal responsibility that must be accepted by each employee.

Every employee has a duty to co-operate with management by:

- a) Working safely and efficiently.
- b) Using protective equipment provided and meeting statutory obligations.
- c) Reporting accidents/incidents that have or could have caused injury/damage.
- d) Adhering to company procedures for securing a safe place of work.
- Assisting in the investigation of accidents with the objective of introducing measures for preventing recurrence.
- f) Identifying potential hazards.

The company endorses the need for joint consultation to maintain the communication necessary for good health and safety standards.

Audits of Health and Safety procedures and inspections of the workplace will be carried out at least annually by management and employee representatives. Any health and safety items identified during the course of inspection will be referred to the Site Director for action.

The Company Policy for Health and Safety will be appraised periodically to determine the need for alteration and revision.
